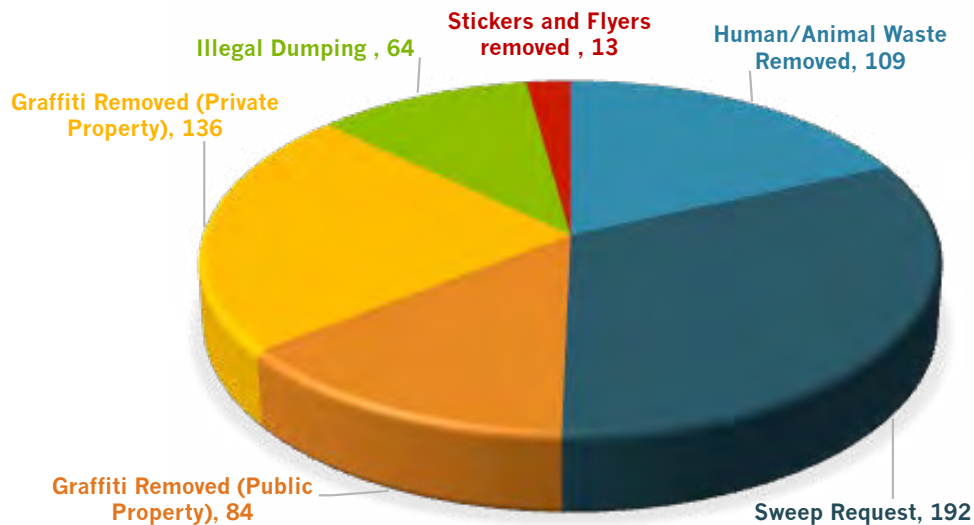

During the City's COVID-19 shelter-in-place ordinance, the Mid Market Community Benefit District (MMCBD) continues to monitor and address conditions on our District's sidewalks within our purview. This includes daily documentation and reporting of encampment issues near your property.

Due to COVID-19 shelter-in-place ordinances the City is implementing encampment protocols per [CDC guidelines](#) through the Healthy Streets Operations Center (HSOC) or 311.

MMCBD's dedicated and hard-working team continues to provide sidewalk clean and safe services when and where it is possible and safe to do so. Regular and on-call pressure washing continues, as does graffiti abatement, vandalism repair and Ambassador services. Please continue to contact our Dispatch office as often as is necessary for service during our current hours of operation below. **If a task must be addressed by a City agency, we will make that request and follow up to ensure it is completed.*

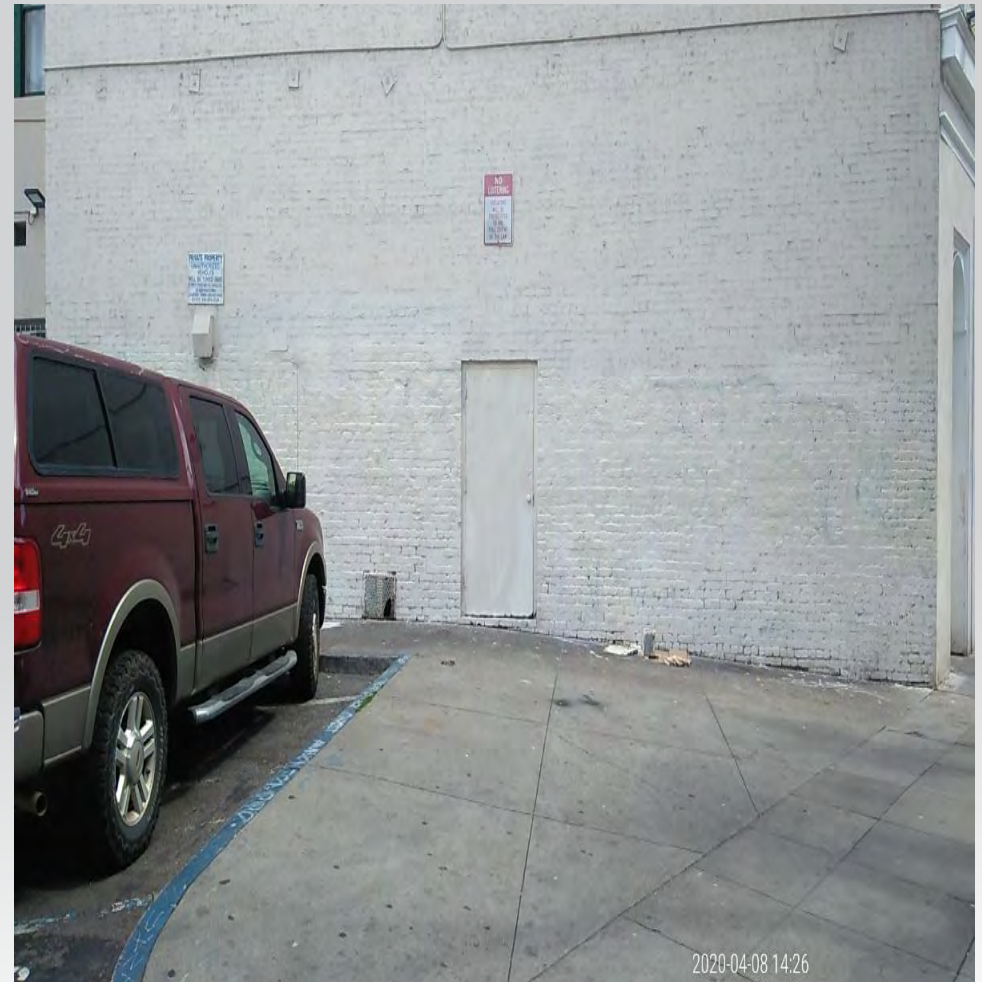
