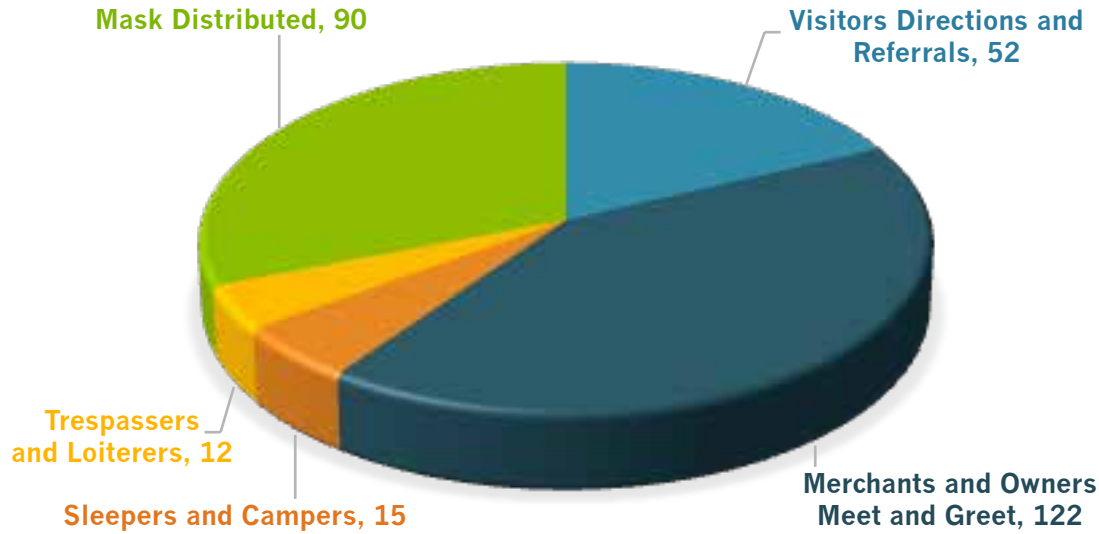

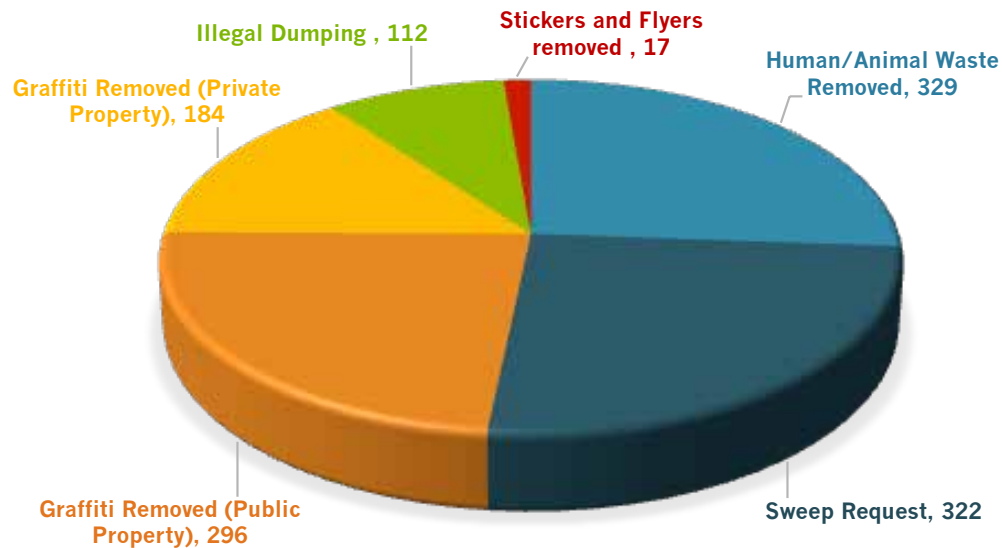

The City's shelter-in-place ordinance (influenced by [CDC guidelines](#), not to move tent encampments) allowed tents to remain on District sidewalks.

MMCBD was only able to clean around encampments (when possible and safe to do so) and to help the city track tent counts and locations.

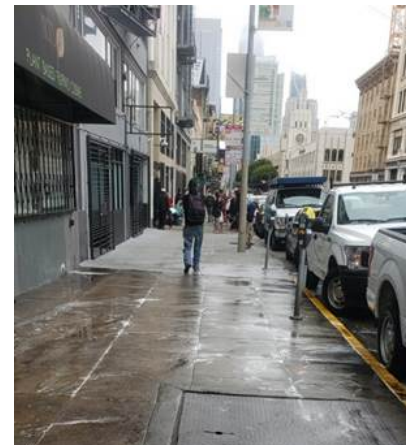

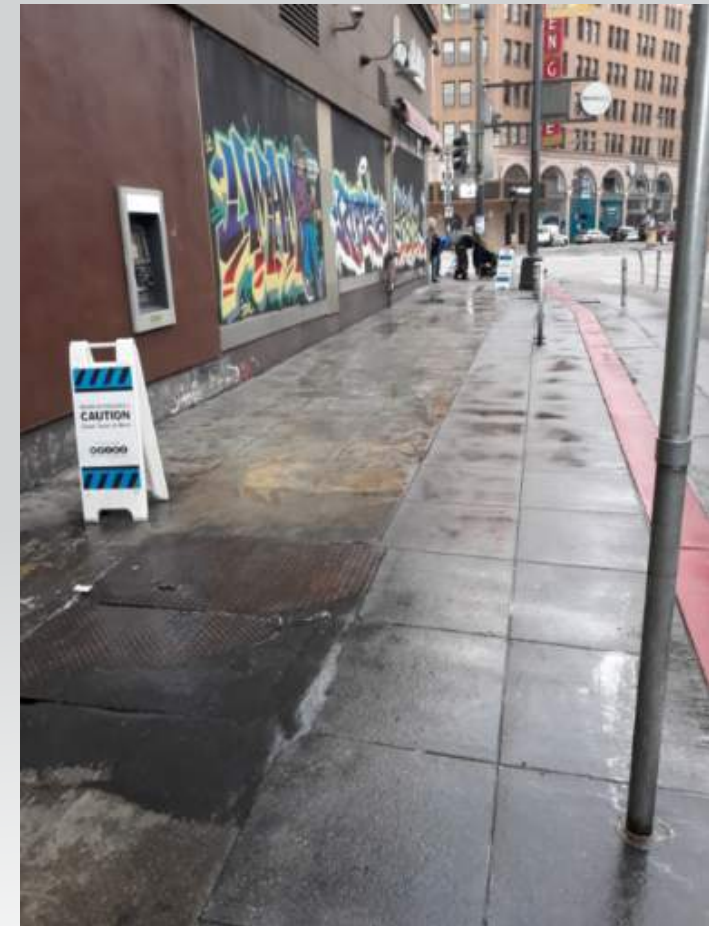
