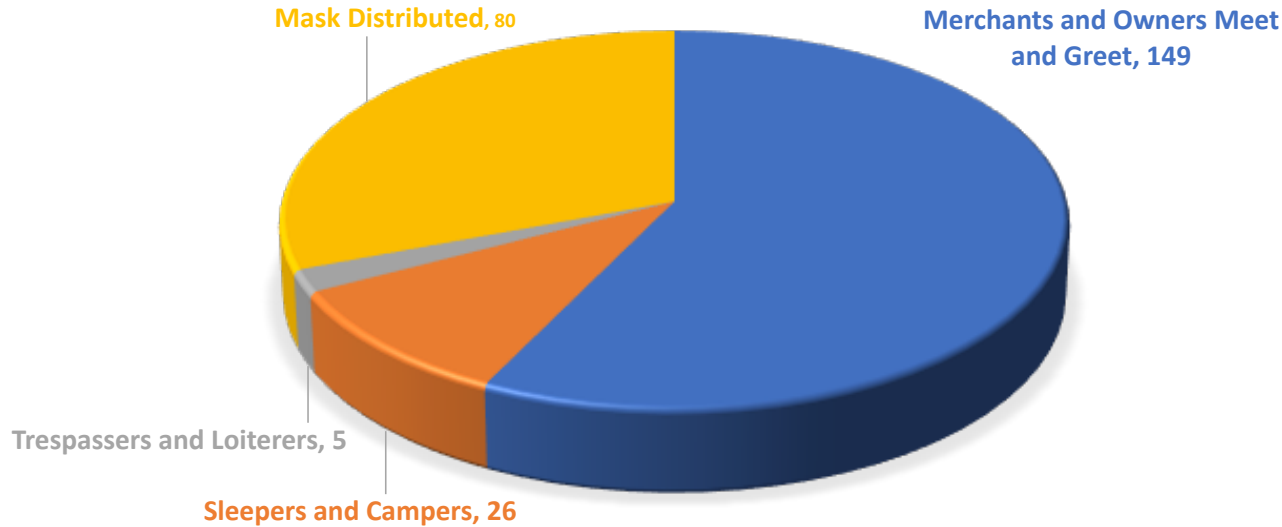

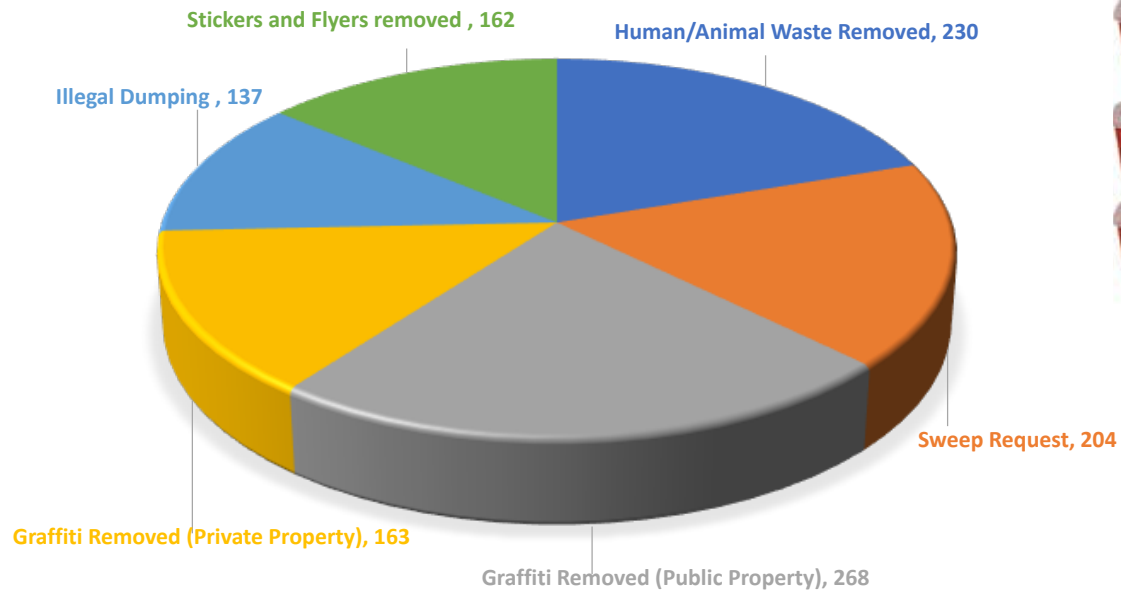

The City's shelter-in-place ordinance (influenced by **CDC guidelines**, not to move tent encampments) allowed tents to remain on District sidewalks.

MMCBD was only able to clean around encampments (when possible and safe to do so) and to help the city track tent counts and locations.

MMCBD also distributed the following to impacted property owners.

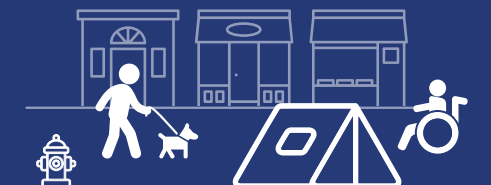

Safe Sleeping Guidance



We are all safer from COVID-19, fires, health issues and traffic hazards when sidewalks and public restrooms are free from overcrowding of tents, people and belongings.

Safe and calm streets have:

Distance between neighboring tents
(at least 3 feet apart)

Clear doorways, windows and entrances
(at least 6 feet)

Clear transit stops, public restrooms and bike stands
(at least 6 feet)

Clear fire hydrants and fire escapes
(at least 5 feet)

Clear sidewalks for pedestrians
(at least 4 feet wide sidewalk path)

Clear driveways, medians and roadways

Please keep our streets litter free.
